# Share plan online portal upgrade



# Computershare, our share plan administrator, is upgrading our online portal to a new platform:

## **EQUATEPLUS**

From **29.7.2019** on, LafargeHolcim shareholders and long-term incentive plans participants will be able to access and manage their share plans through **EquatePlus** (<a href="www.equateplus.com">www.equateplus.com</a>). At the same time, the current portal <a href="http://www.computershare.com/lafargeholcim">http://www.computershare.com/lafargeholcim</a> will be deactivated.

All information that participants have provided in our current portal will be transferred to **EquatePlus**. Participants will be able to keep an eye on their portfolio in no time.

The new portal will bring a clear overview of share plans' performance and provide simple procedures for trades and transfers. Participants will also be able to use the new portal's mobile app to keep track of and manage their portfolio and use task reminders and links to plan opportunities.

### How to access the new portal

The new portal will be available from **29.7.2019** onwards. Participants will receive an email from **EquatePlus** with their new **EquatePlus User ID** and instructions on how to complete the upgrade.

The **new User ID email** will be sent to the email address, participants have on file in our current portal.

If participants are not sure which email address this is, they can check by logging in <a href="http://www.computershare.com/lafargeholcim">http://www.computershare.com/lafargeholcim</a> **before 26.7.2019** and viewing their profile information.

#### Important note for the LafargeHolcim shareholders and long-term incentive participants

- Please make sure that your details are correct and up to date.
- Your current User ID will be deactivated
- You will not be able to use your current login ID and password to access EquatePlus.
   Please look out for the new User ID email from EquatePlus and complete your upgrade as soon as it arrives.
- Computershare's new EquatePlus portal comes with the added advantage of a mobile app, which you can download once you have set up your account.
- You will need your new EquatePlus User ID and password to log in to the mobile app

   so make sure you complete your EquatePlus account set up, to download and start using the app!




